- Employers' feedback indicated that they were happy with the college's facilities and training.

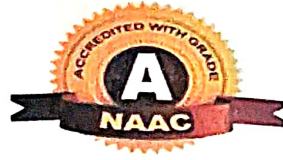

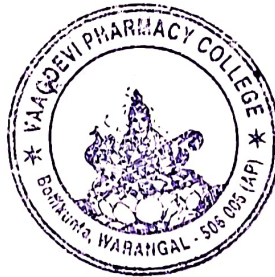
